The Centre for Management Development (CMD) on behalf of the National Health Mission (NHM) – Kerala invites applications from eligible and qualified candidates for positions of Medical Officer (Ayurveda), Medical Officer (Homoeo), Dental Surgeon on contact basis in Kannur district. Interested candidates may apply via **ONLINE** mode only by filling the prescribed application form given in the website of Centre for Management Development (CMD), Thiruvananthapuram (www.cmd.kerala.gov.in). The online application submission link will be open on **28/02/2024 (10.00 A.M.)**. The last date for submitting the online application will be **10/03/2024 (05.00 P.M.)**.

GENERAL TERMS AND CONDITIONS:

- Candidates have to remit an amount of Rs. 500 plus Transaction charges as application fee through online for applying each post.**
- The applicants are required to go through the detailed notification carefully and decide themselves about their eligibility for this recruitment before applying and enter the particulars completely online through (www.cmd.kerala.gov.in)
- NHM/CMD is not responsible for any discrepancy in submitting the application through online.
- Applicants must compulsorily fill up all relevant fields of applications and submit application through online.
- Educational qualifications should be from a University/Institution/Board recognized by Govt. of India/approved by Govt. Regulatory Bodies.**
- The Name of the candidate should be spelt correctly in the application as it appears

- in the Certificates/Mark sheets/Identity proof. Any change/alteration found may disqualify the candidature.
7. **If the applicant possesses an equivalent qualification, he/she should also upload the equivalency certificate along with the qualification certificate or else the application will not be considered.**
 8. Applicants need to upload a valid certificate for every experience he/she mentioned. In the case of the latest/current experience an affidavit bearing all details (name of organization, designation, period, task and duties) shall be uploaded. The copy of appointment letters, salary certificates, pays slips etc. will not be accepted in lieu of work experience certificate.
 9. Decision of the concerned authority in all matters relating to recruitment will be final and binding on the candidates. No correspondence or personal enquiries shall be entertained in this regard.
 10. While applying online for the post, the applicant should ensure that he/she fulfills the eligibility and other norms mentioned above as on the specified dates and that the particulars furnished by him/her are correct in all respects. In case it is detected at any stage of recruitment that a candidate does not fulfill the eligibility norms and/or that he/she has furnished any incorrect/false information or has suppressed any material facts, his/her candidature will stand cancelled. If any of these shortcomings is/ are detected even after appointment, his/her services are liable to be terminated.
 11. Incomplete / incorrect application form will be summarily rejected. CMD/NHM under any circumstances will not entertain the information, if any, furnished by the applicant subsequently. Applicants should be careful in filling up the application form at the time of submission.
 12. If any lapse is detected during the scrutiny, the candidature will be rejected even though he / she comes through the final stage of recruitment process or even at a later stage.
 13. The applicant should not furnish any false, tampered, fabricated information or suppress any material information while filling up the application form. If the particulars furnished in the online application form do not tally with the original documents produced by the applicants, his / her application will be rejected.
 14. Applicants should have a valid personal email ID and mobile no., which should be kept active till the completion of this recruitment process. CMD / NHM may send intimation to download call letters for written test through the registered email ID. In case, an applicant does not have a valid personal email ID, he / she should create his / her new email ID and mobile no. before applying online and must maintain that email account and mobile number.
 15. The copy of the Appointment letters, Salary certificates, pay slips etc. will not be accepted in lieu of work experience certificate.
 16. No TA/DA will be paid for the interview.
 17. Canvassing in any form will lead to automatic disqualification. Candidates are advised to desist from such unholy practices.
